

## Build-A-Bear Workshop, Inc. Changes 2006 Fourth Quarter Earnings Report Date to Tuesday, February 20

ST. LOUIS--(BUSINESS WIRE)--Feb. 12, 2007--Build-A-Bear Workshop, Inc. (NYSE: BBW), an interactive, entertainment-based retailer of customized stuffed animals, has changed its 2006 fourth quarter earnings report date to Tuesday, February 20, 2006; the report was previously scheduled for Thursday, February 15.
