**Explanation of Responses:**

- Grant to reporting person of 7,424 shares of restricted stock. The shares vest in equal annual installments over four years from the date of grant.

- Grant to reporting person of 14,677 shares of restricted stock. These shares have three year cliff vesting and are granted subject to the shareholder approval of additional shares for the Company's Amended and Restated 2004 Stock Incentive Plan. These shares will be forfeited if the additional shares are not approved by the shareholders at the Issuer's annual meeting on May 14, 2009.
- After giving effect to the transaction reported in this Form 4, Ms. Kroll directly beneficially owns 4,374 shares of common stock and 29,600 shares of restricted stock of Build-A-Bear Workshop, Inc. In addition, Ms. Kroll holds vested options to purchase 16,500 shares and unvested options to purchase 14,280 shares of Build-A-Bear Workshop, Inc. common stock.
- The options vest in equal annual installments over four years from the date of grant.
- Price is not applicable to acquisitions resulting from grants of stock options.
